# About Restoring Oaks Inc

- Restoring Oaks is a Florida based 501c3 nonprofit community alliance to prevent and end human trafficking

#### What is Human Trafficking?

- There are two major forms of trafficking
  - Sex trafficking is the recruitment, harboring, transportation, provision, obtaining, patronizing, or soliciting of a person for the purposes of a commercial sex act, in which the commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such an act has not attained 18 years of age (22 USC § 7102).
  - Labor trafficking is the recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud, or coercion for the purposes of subjection to involuntary servitude, peonage, debt bondage, or slavery, (22 USC § 7102).

What laws are in place for prosecuting human trafficking and protecting victims and survivors?



#### The A-M-P Model

- Action + Means + Purpose = Human Trafficking
- Action Harboring, Recruiting, Transporting, Providing,
   Obtaining, Patronizing, Soliciting, and Knowingly Advertising
- Means Force, Fraud, Coercion
- Purpose A commercial sex act, labor or services
- All three of these are required to prosecute adult labor and sex trafficking cases, and minor labor trafficking cases
- Means is NOT required for cases of sex trafficking of minors



### How Human Trafficking is Prosecuted

- Force Physical Restraint, physical harm, and sexual assault
- Fraud False promises regarding employment, wages, working conditions, love, marriage, or a better life
- Coercion Threats of serious harm, physical restraint, psychological manipulation, document confiscation, and shaming
- In order to prosecute human trafficking, at least one of these elements need to be present

#### Newly Introduced Bills

#### Penalties if Prosecuted for Human Trafficking

- If someone is found guilty of using forced labor, they can be fined and face up to 20 year imprisonment (more if death happens from labor) 18 U.S. Code § 1589. Forced labor
- If someone is found guilty of sex trafficking of persons 14 years old and under, they can be fined and face 15 years to life in prison. If found guilty of sex trafficking of persons between 14-18 years old, they can be fined and face 10 years to life in prison. 18 U.S. Code § 1591.Sex trafficking of children or by force, fraud, or coercion
- On top of prison sentences and fines, the law states that victims of trafficking should receive mandatory restitution by the defendant. 18 U.S. Code § 1593.Mandatory restitution
  - Around 36% of trafficking survivors actually get rewarded restitution. <a href="https://www.htlegalcenter.org/wp-content/uploads/2018-Mandatory-Restitution-Report.pdf">https://www.htlegalcenter.org/wp-content/uploads/2018-Mandatory-Restitution-Report.pdf</a>

- U.S. Department of Homeland Security (DHS)
- Federal Bureau of Investigations (FBI)
- Attorney General
- The Justice Department
- Human Trafficking Protection Unit (HTPU)
- Local Law Enforcement
- Social Service, Awareness and Prevention Services
- US Health and Human Services



#### Challenges of Prosecuting Human Trafficking

- Traffickers know what they are doing and the network is vast
- Prosecutors must show that the victim was in fact being trafficked against their will, which means prove the victim/survivor's state of mind
- Lack of awareness or willingness of industries to ask the right questions
- Prosecutors may have to charge traffickers for other offenses like weapons charges or visa fraud
- Businesses who are involved in trafficking may get shut down but reopen under a different name, i.e. massage parlors
- Often adults and minors who are trafficked are either in the foster system or are homeless
- Sometimes victims will not cooperate because of threats by the trafficker or a false sense of security

What can I do to help those who are on the frontlines prosecuting human trafficking?



#### How you can help

- Familiarize yourself with the laws in place
- Attend trainings in your community or specific to your industry
- If you see anything suspicious, report it
- Help those who are in a potential trafficking situation get the help they need
- Help stop the demand by helping educate the community
- Write letters to our local, state and governing thanking them for the work their doing and telling them to do more.

# Assistant Attorney General Eric Dreiband - May 7<sup>th</sup>, 2019 at the Human Trafficking Summit

"Through these strong strategic partnerships with law enforcement and non-governmental anti-trafficking advocates, the Department has brought over 800 federal trafficking cases against approximately 1,800 defendants since Congress passed the Trafficking Victims Protection Act [in 2000].

These prosecutions are all in addition to...child sex trafficking cases that do not require proof of coercion, and that are led by the...the Justice Department's Criminal Division.

We secured convictions on behalf of a young child brought here from West Africa and held in domestic servitude without pay for sixteen years...[another] young woman from New Hampshire whose sex trafficker preyed on her opioid addiction to compel her to prostitute for his profit. We...vindicated the rights of hundreds of Thai women exploited throughout the United States by a transnational sex trafficking organization. In another case, we vindicated the rights of dozens of young women and girls lured into the United States from Mexico on false promises of love, marriage, and a better life.

Together with all of you and many others, we are utilizing time-tested effective strategies: victim-centered approaches to providing the survivors the safety and security they need to come forward; innovative, broad-based partnerships so we can continue uncovering hidden trafficking threats; and the criminal investigations and prosecutions of traffickers that these strategies enable us to bring.

as part of an enforcement action by the Federal Bureau of Investigation, the U.S. Postal Inspection Service, and the Internal Revenue Service Criminal Investigation Division, with analytical assistance from the Joint Regional Intelligence Center.

Other agencies participating in and supporting the enforcement action include the U.S. Attorney's Office for the District of Arizona, the U.S. Department of Justice's Child Exploitation and Obscenity Section, the U.S. Attorney's Office for the Central District of California, the office of the California Attorney General, and the office of the Texas Attorney General.

- "In fiscal year 2019, [Homeland Security Investigators] HSI initiated 1,024 investigations with a nexus to human trafficking and recorded 2,197 arrests, 1,113 indictments, and 691 convictions; 428 victims were identified and assisted." ICE Human Trafficking Page
- 11,500 reported cases of human trafficking and 808 crisis cases through the Human Trafficking Hotline. <u>Polaris</u> <u>Project 2019 Annual Report</u>
- 518 arrested in California during statewide effort "Operation Reclaim and Rebuild" in early 2020
